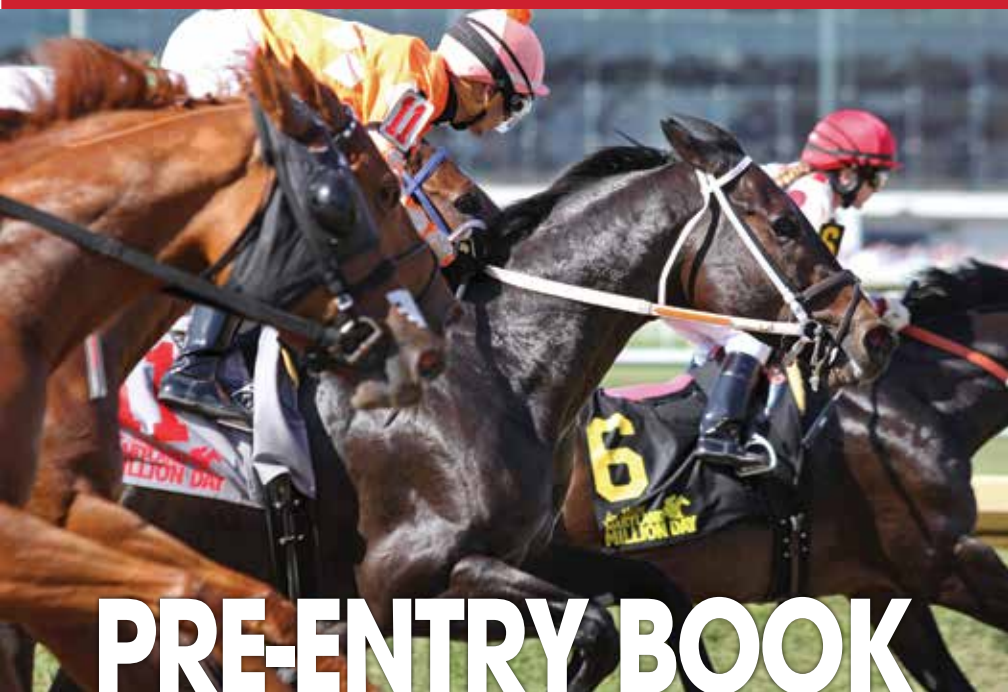

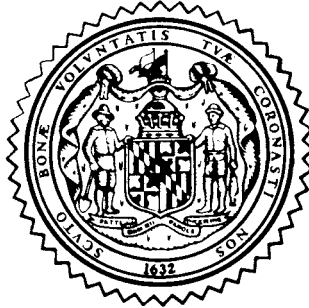

Maryland Million Ltd. shall have no liability for the actions of any official or employee of the track where such races are held or for any matter under the track's control. Purses and award payments shall be made to the owners or lessees recognized as such by the track and the Maryland Racing Commission.

Maryland Million Ltd. reserves the right to broadcast, televise or record Maryland Million races and the activities incident to them, and to exploit same by any means.
